## MOTION OF TIMBER CREEK SEWER COMPANY FOR EXPEDITED CONSIDERATION OF UNANIMOUS STIPULATION

COMES NOW Timber Creek Sewer Company (Timber Creek) by its counsel, Jeremiah D. Finnegan, and for its Motion for Expedited Consideration of the Unanimous Stipulation states as follows:

- 1. On January 4, 2008, the parties hereto filed a Unanimous Stipulation which stated that the Parties have reached an agreement that resolves the only remaining issue in this case, the CIAC connection fee. If accepted by the Commission, the agreement will dispose of all issues in this case.
- 2. Pursuant to the Unanimous Stipulation, on January 10, 2008, the Staff filed its Suggestions in Support of Unanimous Stipulation.
- 3. That the ten day time limit for responding to such pleading pursuant to Rule 4 CSR 240-2.080 (15) has passed without any response being filed.
- 4. In support of its motion for expedited consideration, Timber Creek states: a) that it is seeking a ruling by the Commission approving the Unanimous Stipulation in time to allow Timber Creek to make permanent its CIAC rates by February 1, 2008; b) that if approved by such date, Timber Creek will avoid the harm of continuing to have its CIAC rates in effect on

an interim basis subject to refund for another month and there will be no negative effect on Timber Creek's customers, if the Commission acts by the desired date, since such rates would have already been in effect, albeit on an interim basis on such date, and no party is opposed to the relief; and c) that the pleading was filed as soon after the ten day period for response expired.

**WHEREFORE**, Timber Creek respectfully requests that the Commission grant its motion to approve the Unanimous Stipulation on an expedited basis so that it can place its CIAC rate in effect on a permanent basis no later than February 1, 2008.
