Pursuant to the Company's Purchased Gas Adjustment Clause enclosed are an original and three copies of the Company's Summer PGA Filing. This filing reflects changes in the Company's RPGA factors for each of its three districts and will decrease annualized revenues by approximately \$2,212,410 in Southeast Missouri, \$512,125 in Kirksville and \$32,662 in Butler. The changes in the factors are reflected on the "Adjustment Statement", 13th Revised Sheet Number 16T which cancels the 12th Revised Sheet Number 16T of the Company's tariffs.
