ORDER DIRECTING STATUS REPORT

On March 1, 2023, the Commission issued an order directing the Staff of the Commission (Staff) to provide a status report by March 24, 2023 on whether S. K. & M. Water and Sewer Company (SK&M) has complied with the terms of a certain disposition agreement in this matter between SK&M and Staff, dated September 13, 2022. On March 24, 2023, Staff filed its status report stating that SK&M has complied with conditions 10(c), (h), (j) and (k) of the disposition agreement, but had not yet received everything needed to confirm compliance with condition 10(b).

In its status report, Staff proposes to file another status report regarding SK&M's compliance with the disposition agreement no later than April 24, 2023. The Commission will order Staff to do so.

THE COMMISSION ORDERS THAT:

1. Staff shall file a status report on SK&M's compliance with the disposition agreement approved by the Commission in this matter no later than April 24, 2023. Staff shall also advise the Commission on whether this file may be closed.

2. This order shall be effective when issued.
