The parties have discovered that when the interconnection agreement was filed, a few of the rates in the interconnection agreement were incorrectly shown. Therefore, the parties submit the joint errata to correct the conformed interconnection agreement and move the Commission to modify its August 12, 2005, Order Approving Arbitrated Interconnection Agreement to incorporate its approval of the August 9, 2005, filing as corrected by this errata.

Staff has reviewed the corrected pages and the revised rates on those pages and believes they conform to the Commission's Arbitration Order in TO-2005-0336 and the Act. Under the provisions of the 1996 Act, the Commission may only reject "an agreement (or any portion thereof) adopted by arbitration under subsection (b) if it finds that the agreement does not meet the requirements of section 251, including the regulations prescribed by the Commission, or the standards set forth in subsection (d) of this

section." 47 U.S.C. 252(e)(2). Staff further recommends the Commission direct the Parties to submit any modifications or amendments to the Commission for approval.
