## RESPONSE TO ORDER TO SUPPLEMENT APPLICATION

On April 18, 2014, the Commission issued an order directing Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "the Company"), the applicant in this case, to file a supplement to its application listing each county in which an affected political subdivision – i.e. a political subdivision whose tax revenues may be affected if the Commission approves Ameren Missouri's application – is located.

In paragraph 10 of its application in this case, the Company stated that "because the value of the assets being sold to Silgan is \$50,000, the property and sales tax impacts of the proposed transaction on the City of Union, Franklin County, and the State of Missouri should be minimal." To the best of Ameren Missouri's knowledge and belief, the three political subdivisions identified in that sentence – the City of Union Missouri; Franklin County, Missouri; and the State of Missouri – are the only ones whose tax revenues would potentially be affected if the Commission grants the Company the relief it requests in this case. More specifically, there political subdivisions outside Franklin County that would potentially be affected by this application.
