## FIDELITY NATURAL GAS, INC.'S RESPONSE TO STAFF RECOMMENDATION

Commission's Order Directing Response issued on April 18, 2005, states its response to the

Staff's Recommendation filed on April 14, 2005, as follows:

1. On April 14, 2005, the Commission Staff filed its recommendations following the

completion of the audit of the Actual Cost Adjustment ("ACA") rates for the 2003-2004 period.

The Commission Staff reviewed Fidelity's calculations and made the following

recommendations:

The Staff recommends that the Commission issue an order requiring Fidelity Natural Gas to:

- 1. Adjust the firm sales ACA balance by \$218 increasing the filed over-recovery balance of \$107,494 to the Staff adjusted over-recovery balance of \$107,712, to reflect interest costs associated with (over)/under-recovery ACA balances.
- 2. File a written response to the above three recommendations by May 6, 2005.

(Staff Recommendation, Page 3 of 3).
