**RESPONSE TO STAFF RECOMMENDATION**

COMES NOW Union Electric Company d/b/a Ameren Missouri (Company or Ameren Missouri), and in response to the Staff Recommendation, respectfully states:

1. On February 18, 2011, Ameren Missouri filed its application seeking authority to issue up to \$500 million of new long-term indebtedness.
2. On June 2, 2011, the Staff of the Missouri Public Service Commission (Staff) filed their recommendation in this case. The recommendation contained four conditions upon which Staff's recommendation to approve are conditioned.
3. The Company does not object to the conditions.

WHEREFORE, Ameren Missouri respectfully requests the Commission to approve Ameren Missouri's application and grant it authority to issue up to \$500 million of new long-term indebtedness.
