**JOINT NOTICE OF AVAILABLE DATES FOR HEARING**

**COMES NOW** Ameren Transmission Company of Illinois (ATXI), on behalf of itself, the Staff of the Missouri Public Service Commission (Staff), and the Missouri Joint Municipal Electric Utility Commission (MJMEUC), the Office of the Public Counsel (OPC) (collectively, the Parties), and in accordance with the Commission’s Order of May 10, 2022 states:

1. ATXI filed its Application for a Certificate of Convenience and Necessity and Motion for Expedited Treatment in the above-captioned case on December 21, 2021.
2. MJMEUC filed an application to intervene, which was granted by the Commission on January 14, 2022. Staff and OPC are also parties to this case.
3. On March 30, 2022, the Commission issued an Order Setting a Procedural Schedule, which set the dates for evidentiary hearings as May 11 and 12, 2022.
4. On May 10, 2022, ATXI filed a Motion for Continuance of the Evidentiary Hearing.
5. On May 10, 2022, the Commission granted ATXI’s Motion for Continuance, and directed the parties to file available dates in May and June, 2022 for the hearing, no later than May 12, 2022.
6. In accordance with the Commission’s May 10, 2022 Order, the parties have identified the following dates as available for the Evidentiary Hearing: June 27 - 30, 2022.
7. The parties note that Staff witness Jordan Hull is not available on these dates;

however, no parties have cross examination for Mr. Hull if there are no questions for him from the Commission.

WHEREFORE, the parties hereby request that the Commission accept this Joint Notice in compliance with its May 10, 2022 Order.
