SECTION 1: INTRODUCTION

KCP&L Greater Missouri Operations Company ("GMO"), a Delaware Corporation, has filed its 2012 Annual Renewable Energy Standard Compliance Report in compliance with the Missouri Public Service Commission's ("Commission") Electric Utility Renewable Energy Standard Requirements [4 CSR 240-20.100] ("Rule") that became effective September 30, 2010. Section (7) of the rule requires that each public utility file with the Commission a Renewable Energy Standard ("RES") Compliance Report by April 15 of each year.

Specifically, Section 7 (A) of the Rule requires the following information for the most recently completed calendar year.

- A. Total retail electric sales for the utility, as defined by the Rule;
- B. Total jurisdictional revenue from the total retail electric sales to Missouri customers as measured at the customers' meters;
- C. Total retail electric sales supplied by renewable energy resources, as defined by section 393.1025(5), RSMo, including the source of the energy;
- D. The number of RECs and S-RECs created by electrical energy produced by renewable energy resources owned by the electric utility. For the electrical energy produced by these utility-owned renewable energy resources, the value of the energy created. For the RECs and S-RECs, a calculated REC or S-REC value for each source and each category of REC;
- E. The number of RECs acquired, sold, transferred, or retired by the utility during the calendar year;
- F. The source of all RECs acquired during the calendar year;
- G. The identification, by source and serial number, of any RECs that have been carried forward to a future calendar year;
- H. An explanation of how any gains or losses from sale or purchase of RECs for the calendar year have been accounted for in any rate adjustment mechanism that was in effect for the electric utility;

- I. For acquisition of electrical energy and/or RECs from a renewable energy resource that is not owned by the electric utility, the following information for each resource that has a rated capacity of ten (10) kW or greater:
 - a. Name, address, and owner of the facility
 - b. An affidavit from the owner of the facility certifying that the energy was derived from an eligible renewable energy technology and that the renewable attributes of the energy have not been used to meet the requirements of any other local or state mandate;
 - c. The renewable energy technology utilized at the facility;
 - d. The dates and amounts of all payments from the electric utility to the owner of the facility; and
 - e. All meter readings used for calculation of the payments referenced in part (IV) of this paragraph;
- J. The total number of customers that applied and received a solar rebate in accordance with section (4) of the Rule;
- K. The total number of customers that were denied a solar rebate and the reason(s) for denial;
- L. The amount of funds expended by the electric utility for solar rebates, including the price and terms of future S-REC contracts associated with the facilities that qualified for the solar rebates;
- M. An affidavit documenting the electric utilities compliance with the RES compliance plan as described in this section during the calendar year. This affidavit will include a description of the amount of over- or under-compliance costs that shall be adjusted in the electric utility's next compliance plan; and
- N. If compliance was not achieved, an explanation why the electric utility fail to meet the RES.

This 2012 Report represents GMO's efforts to achieve the requirements of 4 CSR 240-20.100.

There were no sales of RECs and any RECs acquired were either utilized for calendar year 2012 compliance or left in GMO's NARR account for future use.

Attachment C, which contains HIGHLY CONFIDENTIAL information, contains the meter readings and payments to owner of the facility.

Electrical energy and RECs are acquired through a purchased power agreement from Gray County Wind Energy LLC (GCWE) and Ensign Wind (EW), both under parent NextEra Energy Resources. GCWE & EW designated GMO as the NARR Generator Owner's Designation of Responsible Party which represents that the generator owner has not granted similar authority or permission to any other person for use in NARR or any similar registry or tracking system. Gray County Wind Energy and Ensign Wind supported GMO's efforts to certify the facility with the Missouri Department of Natural Resources. Certification was granted November 23, 2011 for Gray County Wind and December 6, 2012 for Ensign Wind. As designated responsible party, an affidavit is attached, Attachment D, by the KCP&L GMO's Manager – Fuels, Emission & RECs

S-RECs were acquired from a wholesale provider or aggregator. These S-REC's were registered in the Western Renewable Energy Generation Information System (WREGIS), a system that has the same information and registration requirements as the Commission selected system, NARR. Purchased S-RECs are transferred from WREGIS to NARR which maintains the integrity and tracking of each S-REC meeting the intent of the Commission's Rule in this instance. The sources of these S-RECs were certified by the Missouri Department of Natural Resources. Certification was initially granted December 19, 2011 and there were not any new additions to that list in 2012. Included in Attachment D is the affidavit from the seller of the S-RECs.

RECs created by generation at Gray County wind farm, located outside the state of Missouri, were utilized for compliance. Energy and associated RECs are acquired through a Purchase Power Agreement with Gray County Wind Energy and Ensign Wind. GMO retired 158,374 vintage 2009 and 2010 RECs in order to meet its 2012 non-solar compliance obligation.

S-RECs were acquired from a third party, 3Degrees Group. GMO retired 3,232 vintage 2010, 2011, and 2012 S-RECs in order to meet its 2012 solar compliance obligation.

The total costs incurred including solar rebates, S-RECs used for compliance, NAR administration, and for systems placed in service in 2012 are:

Compliance costs applied to 2012 for St. Joe Landfill Gas was \$737,466. The cap for determining over- or under- compliance costs was \$10,233,086 and the cost of compliance was \$9,096,964 for an under-compliance cost of \$1,136,122. This will not be adjusted in the next compliance plan.

The utility has made every effort to comply and believes it has achieved compliance with Missouri's Renewable Energy Standard for 2012.

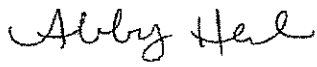

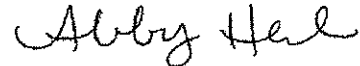
