On July 7, 2022, NextEra Energy Transmission Southwest, LLC (NEET Southwest) filed an application (Application) for a certificate of convenience and necessity (CCN) regarding a 345 kV transmission line. The Commission directed the Staff of the Commission (Staff) to provide its recommendation or a request for an extension of time

on or before August 25, 2022.

Staff timely requested an extension of time of four weeks.<sup>1</sup> Staff requests an

extension to file its recommendation until September 22, 2022.

The Commission finds the extension request reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

1. Staff's request for an extension is granted. Staff shall submit its recommendation, or a request for further extension, on or before September 22, 2022.
