NOTICE OF SUBMISSION - REVISED APPLICATION SCHEDULE A

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Company” or “Ameren Missouri”), and in compliance with the Missouri Public Service Commission’s (“Commission”) Order Directing Filing dated July 15, 2022, hereby files Revised Application Schedule A. In support of this filing, Ameren Missouri states as follows:

1. On July 7, 2022 Ameren Missouri filed via the Commission’s electronic filing system in File No. EA-2022-0244 an Application for Permission and Approval and a Certificate of Public Convenience and Necessity Authorizing it to Construct a Renewable Generation Facility, which included Application Schedule A.

2. On July 15, 2022 the Commission issued an order directing Ameren Missouri to re-file Schedule A, and ensure that it includes a “list of all electric, gas, and telephone conduit, wires, cables, and lines of regulated and nonregulated utilities, railroad tracks, and each underground facility, as defined in section 319.015, RSMo, which the proposed construction will cross” pursuant to 20 CSR 4240-20.045(6)(B).

3. Pursuant to the Commission’s order, Ameren Missouri hereby submits Revised Application Schedule A, which includes the information required pursuant to 20 CSR 4240-20.045(6)(B) and the Commission’s directive. Ameren Missouri’s revised Schedule A also includes contact information in Ameren Missouri’s possession or available from the public records

for each entity.

WHEREFORE, Ameren Missouri respectfully requests the Commission accept its revised Application Schedule A.
