

ORDER CONTINUING STAY

This Complaint was filed by the Staff of the Commission (Staff) on February 23, 1995. This case was suspended by the Commission pending the outcome of Case No. WA-96-190, which could possibly resolve the Complaint. In addition, Case No. WA-96-190 was stayed pending the resolution of litigation in the state courts.

On April 28, 1997, the Commission issued a Notice asking the parties to advise the Commission as to the status of this matter. The Staff responded by requesting an additional 45-day stay in these proceedings. No response was made by the Respondent.

In light of the various pending cases and complexity of the issues involved, the Commission will grant the request of the Staff and stay these proceedings for an additional 45 days pending some action in Case No's. WA-96-190 and WC-97-152.


IT IS THEREFORE ORDERED:

1. That the request of the Staff is hereby granted and this matter is stayed for an additional 45 days from the effective date of this

order. The Staff is ordered to file a status report in this matter no later than the close of business July 3, 1997.
