ORDER SETTING PROCEDURAL SCHEDULE

On December 29, 1993, this docket was opened as a result of an order by the Commission approving a Stipulation and Agreement in Case No. ER-94-97, for the purpose of performing a customer class cost of service and comprehensive rate design study. On February 4, 1994, the Commission issued an order and notice providing for notice and intervention of proper parties.

On March 10, 1995, the parties filed a joint recommendation requesting the Commission to set a procedural schedule for the completion of the litigation of this matter. Included in the requested schedule are deadlines for the provision of information by KCPL and the holding of technical conferences. The requested schedule is as follows:

The Commission will grant the requested schedule, including the proposed deadlines for the furnishing of information and the conduct of technical conferences.


