ORDER APPROVING TARIFF

On August 30, 1994, the Commission issued an order approving the issuance of area certificates of convenience and necessity to Union Electric Company (UE) for portions of the southeastern part of the state acquired in an arrangement with Arkansas Power and Light. In addition, Union Electric was instructed to file appropriate tariffs in compliance with that order.

On September 16, 1994, and again on September 30, 1994, UE filed tariffs designed to comply with the Commission's order, with an effective date for service of October 20, 1994. On October 17, 1994, the Staff of the Commission filed its recommendation. The Staff stated that it has reviewed the filing and finds it to be in compliance with the Commission's order of August 30, 1994.

In its recommendation, the Staff also noted that a portion of land in Washington County, Missouri, was inadvertently omitted from the original filing of sample tariffs and the application by UE. UE subsequently modified its sample tariff filing by adding this piece of land, and, while the Commission's order does not specifically mention a tract in Washington County, it does approve the application and sample tariffs as modified.

The Staff recommends approval of the tariffs as being in full compliance with the Commission's order of August 30, 1994.

The Commission finds the tract in Washington County to be within the contemplation of its order of August 30, 1994, in accordance with the Staff recommendation in this case, and after review of the tariff filing by UE, the Commission finds the tariffs to be in full compliance with the Commission's order of August 30, 1994, and will, therefore, approve the tariffs for service on or after October 20, 1994.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets, filed September 16 and 30, 1994, by Union Electric Company, are hereby approved for service on or after October 20, 1994:
