#### STATUS UPDATE

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or Company), and for its *Status Update*, states as follows:

- 1. On January 22, 2009, the Missouri Public Service Commission (Commission) opened this case in order to consider a request for a change of electric supplier made by Jerry and Sharon West (the Wests).
- 2. The Commission's Order directed AmerenUE and Cuivre River Electric Cooperative, Inc. (Cuivre River) to file a report on the progress in reaching a stipulation of facts by February 27, 2009.
- 3. AmerenUE and Cuivre River have had discussion about this pleading, but AmerenUE has not had time to reduce that conversation to writing. Additionally, AmerenUE has not had time to discuss the stipulation of facts with the Wests.
- 4. AmerenUE still believes a stipulation of facts will greatly simplify this case and will work towards the goal of submitting to the Commission a Joint Stipulation of Facts by March 16, 2009.

WHEREFORE, AmerenUE requests the Commission accept this *Status Update* in fulfillment of the AmerenUE and Cuivre River progress report filing requirement contained in the Commission's January 22, 2009 order.
