

REQUEST FOR CANCELLATION OF CERTIFICATE

COMES NOW Stephens Park Medical Building General Partnership ("Stephens Park"), by and through counsel, and hereby files its Request for Cancellation of Certificate, by which it requests that the Commission cancel the Certificate of Authority to Provide Shared Tenant Services within the State of Missouri (the "Certificate") issued in Commission Case No. TA-92-58, and in support of such request, states as follows:


1. By Report and Order effective December 17, 1991, the Commission granted Stephens Park's request for the Certificate under which Stephens Park was granted authority to provide shared tenant services ("STS") to tenants in a medical office building owned by Stephens Park, all pursuant to Sections 392.440 and 392.520, RSMo.
2. Pursuant to the Certificate, Stephens Park provided STS to tenants in such building.
3. Subsequently, Stephens Park sold said building and has ceased to provide STS to such tenants, or any tenants, and has no plans to provide STS in the future.
4. Stephens Park is therefore not acting as a public utility within the State of Missouri, and is not providing any public utility services, including STS.

5. Stephens Park therefore hereby requests that the Certificate be cancelled, and that Stephens Park thereby be relieved of any reporting, assessment, or other requirements previously imposed upon Stephens Park pursuant to the Certificate.

WHEREFORE, Stephens Park prays for the Commission's Order canceling the Certificate and thereby relieving Stephens Park of any reporting, assessment, or other requirements previously imposed upon Stephens Park thereby.
