THE UNANIMOUS STIPULATION AND AGREEMENT**

Comes now the Staff of the Missouri Public Service Commission (Staff), and for its Errata Sheets and Suggestions in Support of the Unanimous Stipulation and Agreement (Stipulation) filed March 3, 2008, states as follows:

1. On December 21, 2007, the Commission issued its Order Consolidating Cases and Modifying Procedural Schedule, thereby consolidating Case No. GR-2007-0178 with Case No. GR-2008-0060.
2. On February 13, 2008, settlement discussions between Staff, Missouri Gas Utility, Inc. (MGU or Company) and the Office of Public Counsel (OPC) were initiated.
3. On March 3, 2008, a Unanimous Stipulation and Agreement was filed on behalf of Staff, MGU, and OPC.
4. On March 7, 2008, the Commission ordered the parties to file any corrections to prefiled testimony no later than 5:00 p.m., March 17, 2008, and any suggestions in support of the Stipulation no later than 8:00 a.m., March 19, 2008.
5. Attached hereto are the Staff's Errata Sheets, and the Staff's Suggestions in Support of the Unanimous Stipulation and Agreement.

WHEREFORE, the Staff respectfully prays that the Missouri Public Service Commission approve the Unanimous Stipulation and Agreement filed March 3, 2008, in this matter.
