**SUPPLEMENT TO APPLICATION**

Comes now Applicant Easy Telephone Service Company (“Applicant”), by its undersigned counsel, and to supplement its Application for Commission designation as an Eligible Telecommunications Carrier (“ETC”), states the following:

1. On August 9, 2011, Applicant submitted responses to Staff of the Missouri Public Service Commission’s (“Staff”) First Set of Data Requests. Attached as Exhibit 4 to those responses is Applicant’s Lifeline and Link-Up Certification Form, submitted in response to Staff’s data request number 22.

2. In consultation with Staff, Applicant learned that Staff believes that the Applicant should submit an application for such low income discounts that more closely resembles the generic Missouri Application for Low Income or Disabled Discounts that is approved by the Missouri Universal Service Board.

3. On September 19, 2011, by Supplement to its Application, Applicant informed the Commission that it agreed to Staff’s suggestion, and submitted a revised Lifeline and Link-Up application.

4. Applicant hereby further revises its Lifeline and Link-Up application to remove any reference to disabled discounts. See attached Exhibit A, “Missouri Application for Low Income Discounts,” incorporated herein by reference.

Wherefore, the Applicant requests that the Commission consider this Supplement in its determination to grant ETC status to the Applicant.
