Accompanying this letter for filing via the Commission's Electronic Filing and Information System (EFIS) are revised tariff sheets, which are designed to increase Ameren Missouri's gross annual electric revenues by approximately \$264 million, exclusive of applicable gross receipts, sales, franchise or occupational fees or taxes. Included in this increase is approximately \$126.8 million of anticipated increases in normalized net energy costs above the net energy costs included in base rates in the Company's last general rate proceeding.
