On January 19, 2023, the Commission issued an order directing Staff to provide a status report by February 24 on whether S. K. & M. Water and Sewer Company (SK&M) has complied with the terms of a certain disposition agreement in this matter between SK&M and the Staff of the Commission (Staff), dated September 13, 2022. On February 2, Staff filed its status report stating that SK&M had not yet received everything needed to confirm compliance with conditions 10(b), (c), (h), (j) and (k) of the disposition agreement.

In its status report, Staff proposes to file another status report regarding SK&M's compliance with the disposition agreement no later than March 24. The Commission will order Staff to do so.

## THE COMMISSION ORDERS THAT:

- 1. Staff shall file a status report on SK&M's compliance with the disposition agreement approved by the Commission in this matter no later than March 24, 2023. Staff shall also advise the Commission on whether this file may be closed.
  - 2. This order shall be effective when issued.
