## ORDER DIRECTING STAFF RESPONSE AND SETTING DEADLINE FOR RESPONSES FROM OTHER PARTIES

Effective Date: September 26, 2022

On September 13, 2022<sup>1</sup>, S. K. & M. Water and Sewer Company (SK&M) and the Staff of the Commission (Staff) filed a disposition agreement (Disposition Agreement) purporting to resolve all issues in this matter. The Disposition Agreement agrees to an annual revenue decrease for both the water system and the sewer system and resolves several other issues. The agreement stated that SK&M would file revised tariff sheets to implement the agreed to rates with an October 19, effective date. Per the agreement, SK&M filed proposed revised tariff sheets on September 23. However, in compliance with Commission regulations, those revised tariff sheets bear a November 7 effective date.

The Commission will direct Staff to inform the Commission as whether Staff and SK&M intend for the proposed revised tariff sheets to have an effective date of October 19 or November 7. The Commission will also set a time for any other party to respond to the proposed effective date.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file a response indicating whether Staff and SK&M intend for the effective date of the proposed revised tariff sheets to be October 19 or November 7. Staff's response shall be filed no later than 10:00 a.m. on September 27.

2. Any other response to the effective date of the tariff shall be filed no later than 2:00 p.m. on September 27.

3. This order shall be effective when issued.
