BRIEF OF RESPONDENT OFFICEPLUS CORPORATION OF MISSOURI

Comes now Respondent Officeplus Corporation of Missouri ("Officeplus"), and, pursuant to the Commission's July 9, 2004 and July 27, 2004 Orders in this case, submits its Brief.

On February 17, 2004, the Commission Staff filed a Complaint against Officeplus for failure to file an annual report as required by Section 392.210.1 RSMo (2000). It requests that the Commission authorize its general counsel to bring a penalty action against Officeplus in Circuit Court pursuant to 386.600 RSMo (2000) for failure to file the annual report, based on the statutory penalties set forth in Section 392.210.1.

Officeplus stopped doing business in Missouri on August 18, 1997. On that date, the Missouri Secretary of State issued a Certificate of Rescission certifying forfeiture and administrative dissolution of Officeplus. A copy of this Certificate of Rescission is attached hereto.

Officeplus does not dispute the Commission Staff's assertion that it failed to file a 2002 annual report on a timely basis. However, Officeplus disputes the Staff's conclusion that Officeplus violated Section 392.210.1 and is subject to a penalty action.

The requirement to file an annual report, and the provision for a penalty action, are contained in Section 392.210.1 as follows:

Every telecommunications company shall file with the commission an annual report at a time and covering the yearly period fixed by the commission. . . . If any telecommunications company

shall fail to make and file its annual report as and when required or within such extended time as the commission may allow . . . such company shall forfeit to the state the sum of one hundred dollars for each and every day it shall continue to be in default with respect to such report or answer. . . .

A telecommunications company is defined by Section 386.020 (51) as follows:

"Telecommunications company" includes telephone corporations as that term is used in the statutes of this state and every corporation, company, association, joint stock company or association, partnership and person, their lessees, trustees or receivers appointed by any court whatsoever, owning, operating, controlling or managing any facilities used to provide telecommunications service for hire, sale or resale within this state.

When Officeplus stopped doing business on August 18, 1997 and obtained its Certificate of Rescission from the Missouri Secretary of State, it was no longer a "telecommunications company" as defined by Section 386.020 (51). The effect of this Certificate of Rescission was dissolution of Officeplus pursuant to Section 351.476 (RSMo 2000) of Missouri's General and Business Corporations law. Pursuant to Section 351.476, upon dissolution a corporation continues its existence. However, it may not carry on any business except that appropriate to wind up and liquidate its business. *Mesler v. Director of Revenue*, 983 S.W.2d 605 (Mo. App. 1999). Once a corporation is dissolved, it may not continue business as a going concern. *In re Byrd*, 228 B.R. 435 (Bkrtcy. 1999). Because a dissolved corporation's only purpose is to wind up its affairs, it cannot engage in the activities which define a "telecommunications company" pursuant to 386.020(51): it cannot own, operate, control or manage any facilities used to provide telecommunications service for hire, sale or resale this state. Because Officeplus was not a telecommunications company once dissolved, it was not subject to the requirement of Section 392.210.1 to file an annual report with the Commission. Accordingly, it is not subject to penalties for failure to file the annual report.

The Commission Staff argues on page 3 of its brief that "it can be surmised" that Officeplus was in the process of winding up its affairs, which "could" include the conduct of business in the state of Missouri. However, whether Officeplus could be considered to be "conducting business"

while winding up its affairs is not the relevant question; rather, the relevant question is whether Officeplus was a telecommunications company as defined in Section 386. 020 (51) at the time it failed to file its annual report. The effect of dissolution under Section 351.476 is to prohibit the conduct of any business other than that appropriate to wind up and liquidate the dissolved corporation's affairs, and this would not include conducting the business of a "telecommunications company". Moreover, even if the Commission did consider the winding up of affairs under Section 351.476 to include the activities of a "telecommunications company", Officeplus cannot reasonably be assumed to have been winding up its affairs in February of 2003 (the time frame when Staff's Complaint alleges Officeplus violated the annual report requirement), which was over 5 years after Officeplus dissolved and over 5 years after the Secretary of State issued its Certificate of Rescission.

Officeplus acknowledges that it failed to comply with the requirement that it notify the Commission of its dissolution and discontinuance of services. Officeplus regrets its failure to provide this notification to the Commission. However, the failure to notify the Commission of dissolution does not give rise to the penalty provisions of 392.210.1. Officeplus respectfully submits that its compliance failure in this case is a lesser offense than failure of a telecommunications company currently operating in Missouri to file an annual report. It is reasonable to conclude that for this reason, the legislature did not provide for penalties arising from a failure to notify the Commission of dissolution similar to those which the legislature provided for failure to file an annual report pursuant to 392.210.1.

Officeplus urges the Commission to find that, due to its corporate dissolution, it is not in violation of Section 392.210.1. However, in the event that the Commission finds that Officeplus was required to file an annual report despite its dissolution, Officeplus requests that the Commission in its discretion allow an exception in this case. Section 392.210 gives the Commission authority to exempt a telecommunications company from the necessity of filing annual reports. Officeplus submits that under Section 392.210, the Commission would have the discretion to excuse it from the

annual report requirement, or to excuse it from an action for penalties, due to the circumstance of its dissolution over 5 years ago.



To Whom It May Concern:

OfficePlus Corporation, Charter No. 00277703, Missouri Identification No. 13041673 was incorporated in the State of Missouri on June 24, 1985. According to the 1996 Annual Registration Report for OfficePlus Corporation (a copy of which is attached for reference), the listed President was Jonas Weil and the listed Secretary was Eileen Lambert.

Effective January 16, 1997, OfficePlus Corporation transferred all of its issued and outstanding common stock to ALLIANCE National Incorporated (Nevada corporation) pursuant to a Stock Purchase Agreement dated December 27, 1996. At a meeting of the Board of Directors of OfficePlus Corporation on January 17, 1997, David Beale was appointed as the Chief Executive Officer and President and Alan Langer was appointed as Secretary and Treasurer.

On July 23, 1999, ALLIANCE National Incorporated changed its name to Vantas Incorporated and in June 2000, Vantas Incorporated merged with HQ Global Workplaces, Inc (a copy of the Certificate of Merger is attached). Please be advised that due to foregoing transactions, none of the officers named above are currently employed by OfficePlus Corporation or by its parent company, HQ Global Workplaces, Inc. The current officers of OfficePlus Corporation are: John Halpern, Chief Executive Officer and President and Peter Harris, Vice President and Secretary.

As indicated on the Missouri 1988 through 1994 Annual Registration Reports that are on file with the Missouri Secretary of State (copies of which are attached for reference), OfficePlus Corporation had less than \$200,000 in assets in the State of Missouri and therefore was not liable for submitting franchise taxes or franchise tax reports during such period.

As described herein, the former officers of OfficePlus Corporation are not employed or affiliated with either OfficePlus Corporation or its parent company and therefore we are unable to obtain their signatures on any Missouri Annual Reports. As the current officer of OfficePlus Corporation, I am submitting Annual Reports for years 1997 through 2003. OfficePlus Corporation will also be submitting Franchise Reports for 1997, 1999, 2000 and 2002. Franchise Reports for 1998 and 2001 were previously submitted to the Department of Revenue.
