1. That the Commission has ordered that a hearing take place on the 12th day of December 2006 in this matter.

2. That in accordance with 4 CSR 240-2.100, a party may make a request for the issuance of a subpoena duces teems for the appearance of any witness that the party deems necessary at such hearing.

3. Than *Paul G. Lane*, is an employee of the Respondent, has taken part in, and has made decisions related to, the denial by the Respondent of a waiver in accordance with G.E.T. §6.12.6(c) and has further been solely involved in the consideration of a stipulation tendered by the Complainant to the Respondent in order to attempt to resolve undisputed issues in lieu of, and prior to, the filing of the Complainant's Complaint.

4. That the Complainant considers the appearance by said witness producing the stipulation document to be necessary to the resolution of the issues involved in this case, the bias and prejudice of the Respondent, the arbitrariness and capriciousness of the Respondent, and the subsequent denial of the waiver by the Respondent during the period from November 1, 2003 and the filing of the formal Complaint.

5. That the Complainant verily believes that he cannot receive a fair hearing unless the witness is ordered to appear and to produce at the time of his appearance, the aforesaid "stipulation" document.

6. That attached hereto and made a part hereof is the Commission's proscribed Subpoena Duces Tecum form provided for the issuance of a subpoena duces tecum by the Commission.

7. That the document to be produced and the testimony of the Respondent's employee is material and relevant in this matter; without the aforesaid document and testimony, the Complainant does not believe he can receive a fair, impartial, and complete hearing on this matter.

WHEREFORE, Complainant moves that the Commission, in accordance with 4 CSR 240-2.2.090 et seq. order that the Secretary of the Commission or a law judge sign and issue said subpoena duces tecum and further order it to be served upon the prospective witness.
