On October 15, 2021, the Staff of the Commission filed a motion asking the Commission to approve the appointment of new members to the Relay Missouri Advisory Committee. Staff asks the Commission to appoint Sarah Prechtel as the representative for the deaf position for a three-year term. Further, Staff asks that Cathee Wolford, Executive Director of the Missouri Commission for the Deaf and Hard of Hearing, be recognized and approved as a permanent member.

The Commission will make the requested appointments.
