Pursuant to the order of the Circuit Court of Cole County, Missouri, in Case No. CV195-1071CC, Associated Natural Gas Company (ANG) was authorized to recover certain take-or-pay costs attributable to transportation customers. The recovery period for these costs according to ANG's 11th Revised Sheet No. 16G was designated beginning March 1, 1998 and ending February 29, 2000 except that the Company may implement early or delayed termination of the factor to minimize over- or under-recovery. To minimize over-recovery of these costs, ANG is requesting approval of 18th Revised Sheet No. 16T to terminate the "Court-Ordered TOP" factors. This filing is not a scheduled or unscheduled PGA filing.

The attached original 18th Revised Sheet No. 16T and three copies bear an issue date of January 14, 2000 and an effective date of February 14, 2000. To avoid over-recovery of these costs, ANG requests implementation of the revised rate on February 1, 2000.
