LEVEL 3 COMMUNICATIONS, L.L.C.'S RESPONSE TO AT&T COMPANIES' REPLY TO LEVEL 3

Level 3 Communications, Inc. ("Level 3"), through undersigned counsel and pursuant to the Commission's October 22, 2007, <u>ORDER GRANTING MOTION TO EXTEND FILING DEADLINE</u>, <u>DIRECTING FILING</u>, <u>AND FURTHER SUSPENDING TARIFF</u>, submits this response to AT&T Companies' Reply to Level 3 (AT&T Reply) filed in this case on October 11, 2007.

- 1. Level 3 disagrees with AT&T's suggestion that there needs to be further investigation and hearing on the pending tariff, and finds AT&T Companies' concerns are unfounded and exaggerated. However, in the interest of addressing the concerns and questions raised, and facilitating resolution of any issues regarding its tariff filing, Level 3 has prepared the attached "white paper" outlining the history and applicability of the proposed tariff revisions.
- 2. In its October 1, 2007, Reply to AT&T and Embarq, Level 3 stated: "Nonetheless, in order to address any confusion, Level 3 is currently working with staff to provide clarification regarding the revisions to Tariff No. 4 and will make any appropriate revisions based upon those discussions." In addition to preparing the attached "white paper", Level 3 is also in the process of preparing revised tariff pages to

implement changes to the proposed tariff revisions. A copy of the revised tariff pages

will be submitted shortly both in this Docket and in Tariff No. JC-2008-0133.

3. The attached "white paper" and the revisions to the tariff filing should resolve

all concerns, and the Commission should permit Level 3's tariff filing to take effect on

the date to which it has been suspended; that is November 27, 2007.

WHEREFORE, Level 3 files this Response to AT&T Companies' Reply and

respectfully requests that Tariff No. JC-2008-0133 be allowed to take effect on

November 27, 2007.
