The Telecommunications Department Staff (Staff) recommends the Parties be granted approval of the submitted:

The parties submitted the proposed Agreement or Amendment to the Missouri Public Service Commission (Commission) pursuant to the terms of the Telecommunications Act of 1996 (Act). Although the application requests the Commission issue an Order to Recognize the Adoption of the Interconnection Agreement and approve the First Addendum to the Interconnection Agreement, the Staff recommends that the Commission's Order approve only the Amendment (Addendum). Pursuant to 4 CSR 240-3.513(4)(A), adoption of Interconnection Agreements Previously Approved by this Commission are deemed approved on the date they are properly submitted. The parties filed a letter indicating that Rystec, Inc. was adopting an agreement previously approved by the Commission in Case No. TK-2006-0126 and included a copy of the signature page signed by both parties to the adoption. Thus, pursuant to Commission rules, the Adoption of the Interconnection Agreement is deemed approved on September 13, 2006.


