ORDER DIRECTING NOTICE AND JOINING DOBSON CELLULAR
SYSTEMS, INC. AS A PARTY

Issue Date: January 3, 2007

Effective Date: January 3, 2007

Syllabus: This order provides notice of this application to interested parties and joins the other party to the interconnection agreement, Dobson Cellular Systems, Inc. ("Dobson"), as a party to this proceeding.

On December 26, 2006, Holway Telephone Company ("Holway") filed an application with the Commission for approval of a negotiated interconnection and reciprocal compensation agreement with Dobson under the applicable provisions of the federal Telecommunications Act of 1996. In its application, which appears to be in substantial compliance with all filing and submission requirements specified by Commission Rules 4 CSR 240-2.060 and 4 CSR 240-3.513, Holway states that the negotiated agreement complies with Section 252(e) of the Act in that it is consistent with the public interest, convenience and necessity, and is not discriminatory to nonparty carriers. Holway requests expeditious approval of the agreement.

Although Dobson is a party to and signatory of the agreement, it did not join in Holway's application. Because Dobson is a necessary party to a full and fair adjudication of this matter, the Commission will join Dobson as a party to this case.

The Act provides that a negotiated interconnection or resale agreement must be approved unless the state commission finds that the agreement discriminates against a telecommunications carrier not a party to the agreement, or that implementation of the agreement is not consistent with the public interest, convenience, and necessity.¹ Section 252(e)(4) of the Act provides that if the Commission has not approved an agreement within 90 days after submission, the agreement shall be deemed approved. Therefore, the Commission will proceed with this case expeditiously. The Commission finds that proper persons should be allowed 20 days from the date of the issuance of this order to file a motion for intervention or hearing. The Commission also finds that notice of this application should be sent to all interexchange and local exchange telecommunications companies.

IT IS ORDERED THAT:

1. The Commission's Data Center shall send notice of this application to all interexchange and local exchange telecommunications companies operating in Missouri.
2. Dobson Cellular Systems, Inc. is made a party to this case.
3. Any party wishing to intervene or request a hearing shall do so by filing a pleading no later than January 23, 2007, with:
