I do hereby certify that the attached is an accurate and complete copy of the proposed rescission lawfully submitted by the Missouri Public Service Commission.



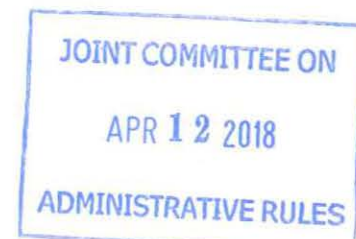
PURPOSE: This rule is being rescinded in its entirety because it is no longer necessary.
