The Commission's REPORT AND ORDER Issued September 20, 2001

On September 26, 2001, The Empire District Electric Company (EDE) filed with the Commission thirty nine (39) tariff sheets with a proposed effective date of October 2, 2001 intended to comply with the Commission's September 20, 2001 REPORT AND ORDER (Order). EDE also filed a Motion For Expedited Treatment And Approval Of Tariff Sheets.

In its Order the Commission authorized EDE to file proposed tariff sheets to increase its revenues by approximately \$17.1 million and approved the Unanimous Stipulation And Agreement Regarding Fuel And Purchased Power Expense And Rate Design filed June 4, 2001.

The Staff has been able to expedite its review of the filed tariff sheets because EDE has provided advanced drafts of the filing and has worked with the Staff on language to implement the Interim Energy Charge (IEC).

The Staff believes that the October 2, 2001 operation-of-law date in this case is good cause for the Commission to order the tariff sheets to become effective on that date.

The Missouri Public Service Commission Energy Department Staff (Staff) has reviewed the filed tariff sheets and is of the opinion that they were filed in a timely manner and are in compliance with the Commission's Report and Order. Staff is not aware of any other matter before the Commission that affects or is affected by this filing. Staff therefore recommends that the Commission issue an order approving the following proposed tariff sheets, as filed on September 26, 2001, to become effective on October 2, 2001:
