Subject: Staff Recommendation for Name Change of Computer Telephone Corp. to CTC Corp.

Date: October 18, 1999

On August 18, 1999, CTC Corp. filed an Adoption Notice to adopt, ratify and make its own, in every respect as if the same had been originally filed by it, all tariffs, schedules, rules, notices, contracts, authorities or other instruments whatsoever, of Computer Telephone Corp., a competitive interexchange telecommunications company. At the same time, CTC Corp. also filed an original tariff, P.S.C. Mo. No. 1.

As part of its filing, CTC submitted copies of the Missouri Secretary of State Certificate of Corporate Records, Certificate of Authority and Application for Foreign Corporation showing the name change from Computer Telephone Corp. to CTC Corp.

On September 8, 1999, CTC submitted substitute tariff sheets and withdrew Original Sheet No. 29. Additional substitute tariff sheets were submitted on September 28 to address Telecommunications Department Staff (Staff) concerns. Staff has reviewed all substitute sheets and finds them acceptable.

Since the Adoption Notice stated CTC plans to adopt the Computer Telephone Corp. tariff and CTC also submitted an original tariff in the new name, CTC submitted a letter on September 9, 1999 to withdraw the Adoption Notice and to request an extension of the effective date to September 24, 1999. CTC filed subsequent letters on September 15 and September 23 requesting an extension of the effective date to October 8 and October 15, 1999 respectively.

On October 6, 1999, an Order and Notice Regarding Change of Corporate Name and Tariff Sheets and Ordering Supplemental Information was issued. The Order indicated that the filings in this proceeding do not include documentation to show a new legal name for the Corporation. To allow time to effectuate the appropriate documentation with the Secretary of State's Office to satisfy the requirements of the Order, CTC submitted substitute sheets on October 6 and 13, 1999, changing the filing to P.S.C. Mo. No. 2 in the name of Computer Telephone Corp. d/b/a CTC Corp. CTC also submitted a request for extension to October 27 and October 29, respectively.

Staff has reviewed CTC Corp.'s P.S.C. Mo. No. 2, Original Sheet Nos. 1 through 28, as amended, and has no objection to the tariff going into effect. Staff also recommends that P.S.C. Mo. No. 1 in
