On March 7, 2000, Teleglobe Business Solutions (TBS) filed an Adoption Notice to adopt, ratify and in every respect make its own as if the same had been originally filed by it, Missouri P.S.C. Tariff No. 1 of Telco Holdings, Inc. d/b/a Dial & Save (THI). THI was certificated to provide interexchange and local exchange telecommunications services on June 29, 1995, in Case No. TA-95-298.

As part of its filing, TBS submitted copies of the Missouri Secretary of State Amended Certificate of Authority of a Foreign Corporation showing the name change from THI to TBS. TBS also submitted a proposed 2nd Revised Sheet No. 1, which contains revisions to the title sheet to reflect the name change.

The Telecommunications Department Staff (Staff) has reviewed the proposed tariff sheets and finds them satisfactory. Staff has no objection to this filing. Staff is unaware of any other filing that would affect or would be affected by this filing.
