STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Status Report, states as follows:

On October 18, 2005, Mr. John B. Jackson left several telephone messages for Staff counsel regarding his pending complaint case and the Commission's October 11, 2005 Order Directing Filing. Staff counsel returned calls to Mr. Jackson but did not get through to him until October 19, 2005. Staff counsel discussed with him the status of his case, and the Commission's Order Directing Filing which directed the Complainant "...to file a response to Staff's Recommendation and Memorandum, and to show cause why his complaint should not be dismissed." Mr. Jackson informed Staff counsel that he received the Commission Order Directing Filing a few days earlier and that he was experiencing some delay in mail delivery. Mr. Jackson further stated that he had sent a fax to the Commission's Secretary's Office via 573-751-1847 and that he intends to submit a response to the Commission. Staff counsel has been unable to locate this fax and so informed Mr. Jackson on a subsequent call. Staff counsel advised

Regulatory Law Judge Vicky Ruth of these matters. Staff counsel informed Mr. Jackson that he could submit his response to the Commission's Order Directing Filing by fax to the Commission at 573-526-6010, attention Judge Ruth.

WHEREFORE, the Staff submits this Status Report to the Commission for its consideration respecting Mr. Jackson's efforts to comply with the Commission's Order Directing Filing.
