## STAFF'S RESPONSE TO PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Missouri Public Service Commission (Staff), and for its Response to the Proposed Procedural Schedule respectfully states:

1. On December 10, 2001, St. Louis County Water Company d/b/a Missouri-

American Water Company, Jefferson City Water Works Company d/b/a Missouri-American Water Company and Missouri-American Water Company (Applicants), filed their Proposed Procedural Schedule.

2. The Staff concurs with the Applicants' decision to withdraw their request that the Commission grant the application for expedited treatment.

3. The Staff has reviewed the proposed procedural schedule submitted by the Applicants and makes the following proposed modifications based on the next hearing dates currently availability on the Commission calendar for a two-day hearing. Also, due to Staff's involvement in significant preparation for a hearing in another case beginning on March 4, 2002, Staff prefers to keep the testimony filing dates as proposed by the Applicants.
