

2. The Parties move that the Commission establish the following procedural schedule in this case:

September 28, 2012:	Big River Direct Testimony (directed to its Complaint) and AT&T Direct Testimony (directed to its Complaint)
October 19, 2012:	Big River and AT&T Rebuttal Testimony
November 9, 2012:	Staff Testimony directed to both Complaints ¹
November 30, 2012:	Big River and AT&T Surrebuttal Testimony
December 14, 2012:	List of Issues, Order of Witnesses, Order of Cross Examination, Time Limits on Opening Statements and Cross/Redirect Examinations
December 14, 2012:	Joint Stipulation of Facts
December 21, 2012:	Position Statements
January 4, 2013:	All Hearing Exhibits filed in EFIS by 11:59 p.m. ²
January 8-9, 2013:	Hearing on the Merits

3. During the pre-hearing conference, the Parties agreed that no discovery requests would be filed in this case after Monday, December 10, 2012, which is 30 days before the first scheduled hearing date.

WHEREFORE, the Parties jointly move the Commission to adopt this proposed procedural schedule and discovery cut-off date.

¹ On July 16, 2012, the Commission ordered Staff to file a report in this case no later than August 29, 2012. However, at the prehearing conference, the presiding officer ordered Staff to file instead its report or testimony according to this procedural schedule.

² The Parties agree that exhibits used for impeachment purposes in the course of cross-examination need not be pre-filed.
