1. On February 17, 2004, the Staff of the Missouri Public Service Commission ("Staff") initiated a complaint pursuant to Section 386.390 and 4 CSR 240-2.070 against Officeplus for failure to file an annual report pursuant to the requirements of 392.210.1 RSMo.
2. Officeplus was granted a certificate of service authority to provide shared tenant services in Case No. TA-89-97 on April 7, 1989.
3. Officeplus is no longer doing business as a Missouri corporation.

WHEREFORE, Officeplus requests that the Commission dismiss the Staff's complaint.
