ORDER DIRECTING NOTICE AND SETTING DATE FOR SUBMISSION OF INTERVENTION REQUESTS

On June 2, 2006, the Staff of the Public Service Commission, the Office of the Public Counsel, New Florence Telephone Company, Robert Williams, and Local Exchange Company, LLC, filed a Stipulation and Agreement that requires New Florence Telephone Company to pay a penalty to resolve Staff's complaint. The Stipulation and Agreement also requires the company to pay certain credits to its customers to resolve concerns about over-earnings by the company. The Commission has scheduled an on-the-record presentation for the purpose of considering the Stipulation and Agreement. That presentation will take place on July 6, 2006, at 1:00 p.m.

The Commission finds that notice of the filing of this Stipulation and Agreement should be given to the general public and to potentially interested parties. A date for intervention of proper parties will also be set. The Commission's Data Center shall mail a

copy of this notice to the County Commission of Montgomery County, as well as to all incumbent local exchange carriers, all competitive local exchange carriers, and all interexchange carriers providing service in Missouri. In addition, the Commission's public information officer shall make notice of this order available to the media serving Montgomery County and to the members of the General Assembly representing Montgomery County.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party is granted intervention and no party requests a hearing, the Commission may determine that a hearing is not necessary.
