1. On October 23, 2007, an evidentiary hearing was held in the above matter. No evidence was presented at the hearing. All parties appeared. Staff was ready to proceed. The Office of Public Counsel was also ready to proceed. Time Warner moved to continue the hearing. The Commission then issued an Order Granting Motion for Continuance and Rescheduling Evidentiary Hearing on November 1, 2007.

2. As part of its agreement not to object to a continuance, Staff requested assurances from Time Warner's that it would not object to Staff supplementing its List of Witnesses, and Time Warner assured that they would not object. (See p. 31 of Transcript Volume 3, lines 2-6)

3. The parties jointly filed a List of Issues, Witnesses and Order of Cross Examination on September 21, 2007. In that document, Staff listed Mr. Myron Couch as the witness it planned to call, the Office of the Public Counsel listed Ms. Barbara Meisenheimer as its witness, and Time Warner listed Mr. Dale Fox as the witness it intended to call.

4. Based on the assurances from Time Warner at the October 23rd hearing, Staff would like to amend its witness list as follows: Mr. Myron Couch is removed from Staff's list

of witnesses, and Mr. Dale Fox from Time Warner is listed as a witness for Staff. Ms. Natelle Dietrich is added to Staff's witness list. Staff reserves the right to call as a witness any witness listed by any other party.

5. The order of cross-examination would not change.
