**MOTION TO ADOPT THE PARTIES' PROPOSED JOINT PROCEDURAL
SCHEDULE**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for the parties' Motion to Adopt the Parties' Proposed Joint Procedural Schedule respectfully states as follows:

1. Staff filed its Complaint in the above-captioned case on April 23, 2007. Notice of the Complaint was issued on April 25, 2007.
2. On June 18, 2007, the Commission held a prehearing conference in this matter. In the Order setting the prehearing conference, the Commission also directed the parties to jointly prepare and file a proposed procedural schedule no later than July 9, 2007.
3. The Complaint remains unresolved as of this date. The parties must therefore propose a procedural schedule to the Commission. Staff counsel has been in contact with counsel for Time Warner Cable Information Services (Missouri), LLC (Time Warner). The parties are in agreement that a satisfactory resolution can likely be reached in this matter before the case proceeds to hearing. The parties have therefore agreed that another prehearing conference would be helpful in order to foster settlement.

In the event that no settlement is reached, the parties can use the second prehearing conference to develop a list of issues and a list of witnesses.

4. The parties stipulate that there will be no prefiled testimony offered in this case.

5 The parties move that the Commission adopt the following procedural schedule:

August 27, 2007	Second Prehearing Conference
September 21, 2007	List of Issues/List of Witnesses
October 23, 2007	Hearing

WHEREFORE, the parties respectfully request that the Commission order the procedural schedule set forth above.
