On May 2, 2018, The Staff of the Public Service Commission filed a complaint alleging that PhoneHost LLC ("PhoneHost") failed to secure proper certification to provide telecommunications services (including voice over internet protocol services) to customers in the area of Excelsior Springs, Missouri.
