- 4. Applicant's current Certificate of Good Standing from the Missouri Secretary of State was attached to the original Application, and is incorporated by reference here.
- 5. Applicant has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three years of the date of this Application.
 - 6. Applicant has no annual report or assessment fees which are overdue.
- 7. By Order dated May 19, 1998 in TA-98-305, Applicant was granted a certificate of service authority to provide basic local exchange telecommunications

services in the exchanges of GTE Midwest Incorporated, which exchanges are now owned and operated by Spectra or Verizon (f/k/a GTE). In that Order Applicant was also granted competitive classification and waiver of certain regulatory requirements not applicable to competitive companies.

- 8. Since said Order, Applicant has obtained approval of tariffs and interconnection agreements, and pursuant to all of these has been operating and actively providing basic local telecommunications service to customers since 1998. - 10. Prior to offering service in the service areas of SWBT and Sprint, it will be necessary for Applicant to obtain approved interconnection agreements with those carriers, and to modify Applicant's tariffs to reflect the terms of those prospective interconnection agreements. As the modified tariffs cannot be prepared at this time, Applicant requests a temporary waiver of 4 CSR 240-2.060(6)(C).
- 11. Granting of the Application is in the public interest in that it will increase competition and increases the number of rural exchanges in which there is competition.
- 12. Applicant will continue to offer basic local telecommunications service as a separate and distinct service.
- 13. Applicant will continue to provide equitable access to all Missourians, subject only to Applicant's service areas, approved agreements, and approved tariffs.

WHEREFORE, Applicant respectfully requests that the Commission grants it an amendment to its initial certificate of service authority expanding the geographic or service areas in which Applicant is authorized to provide basic local telecommunications service to include the service areas of ILECs Southwestern Bell Telephone Company, and Sprint Missouri Inc.
