
Please note the tariff sheet bears an issue of May 17, 2004, and is proposed to become effective on June 17, 2004.

SERVICE CONNECTION FEE

Each applicant for new sewer service will be charged a Service Connection Fee to connect the customer's sewer service to the Company's collecting sewer as follows:

\$2500 for each connection.

The proceeds from this Service Connection Fee will be accounted for separately from other Company funds and will be used solely for making the regularly scheduled principal and interest payments on the Company's loan approved by the Commission in its Case No.

SF 2004-0587 Any proceeds from the Service Connection Fee that are in excess of the regularly scheduled loan payment will be used for prepayment of the principal balance of the loan. In the event the proceeds from this Service Connection Fee are not sufficient to make the regularly scheduled loan payment, the balance of the payment will be made using other Company funds. The Service Connection Fee will be reviewed annually and is subject to change by the Commission based upon changes in the number of customers, billing and collection history or other good cause as the Commission may order. This Service Connection Fee will terminate when the loan approved by the Commission in its Case No. SF 2004-0587 paid off or on August 1, 2010, whichever shall first occur.
