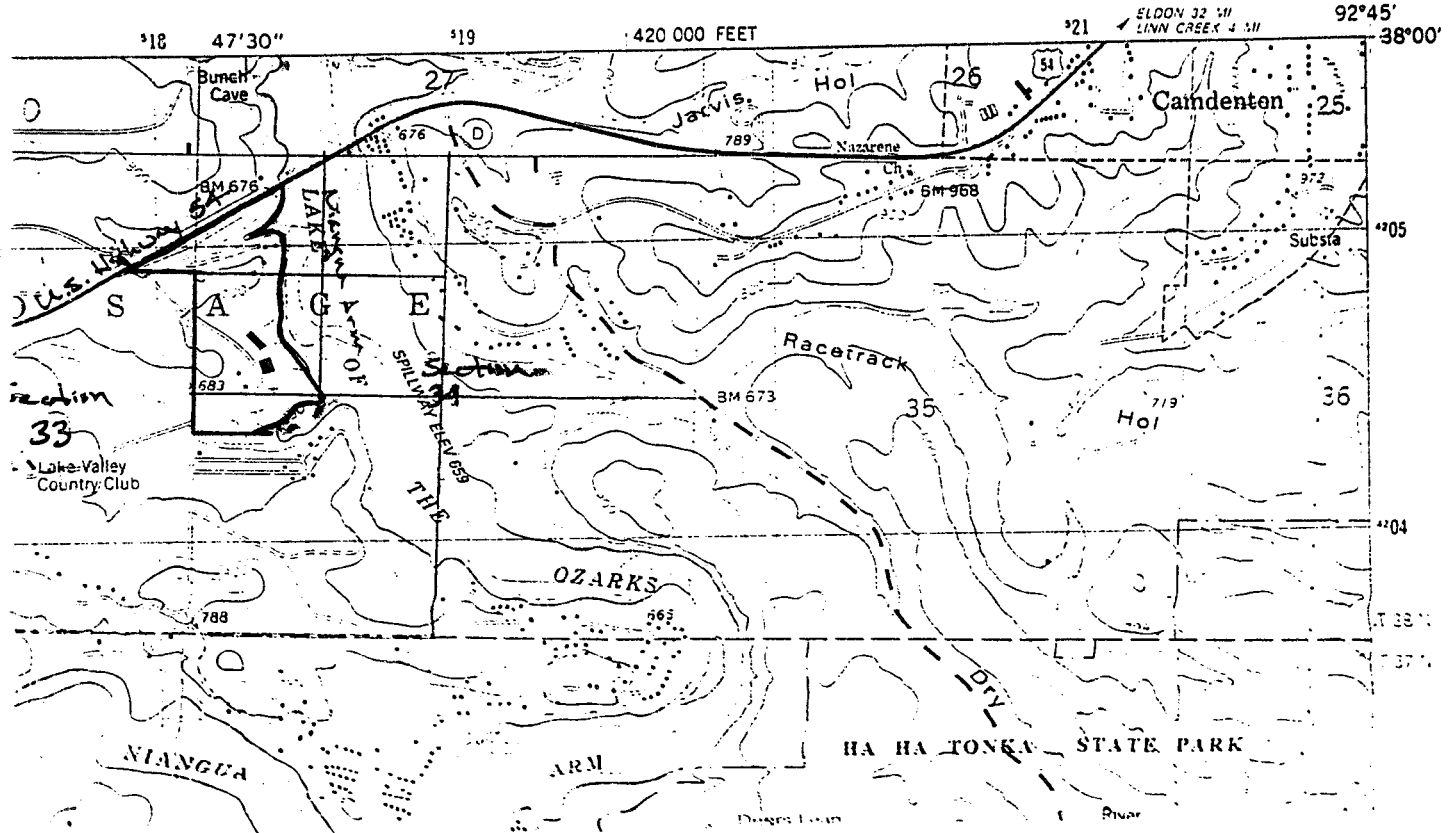
MAP OF SERVICE AREAS

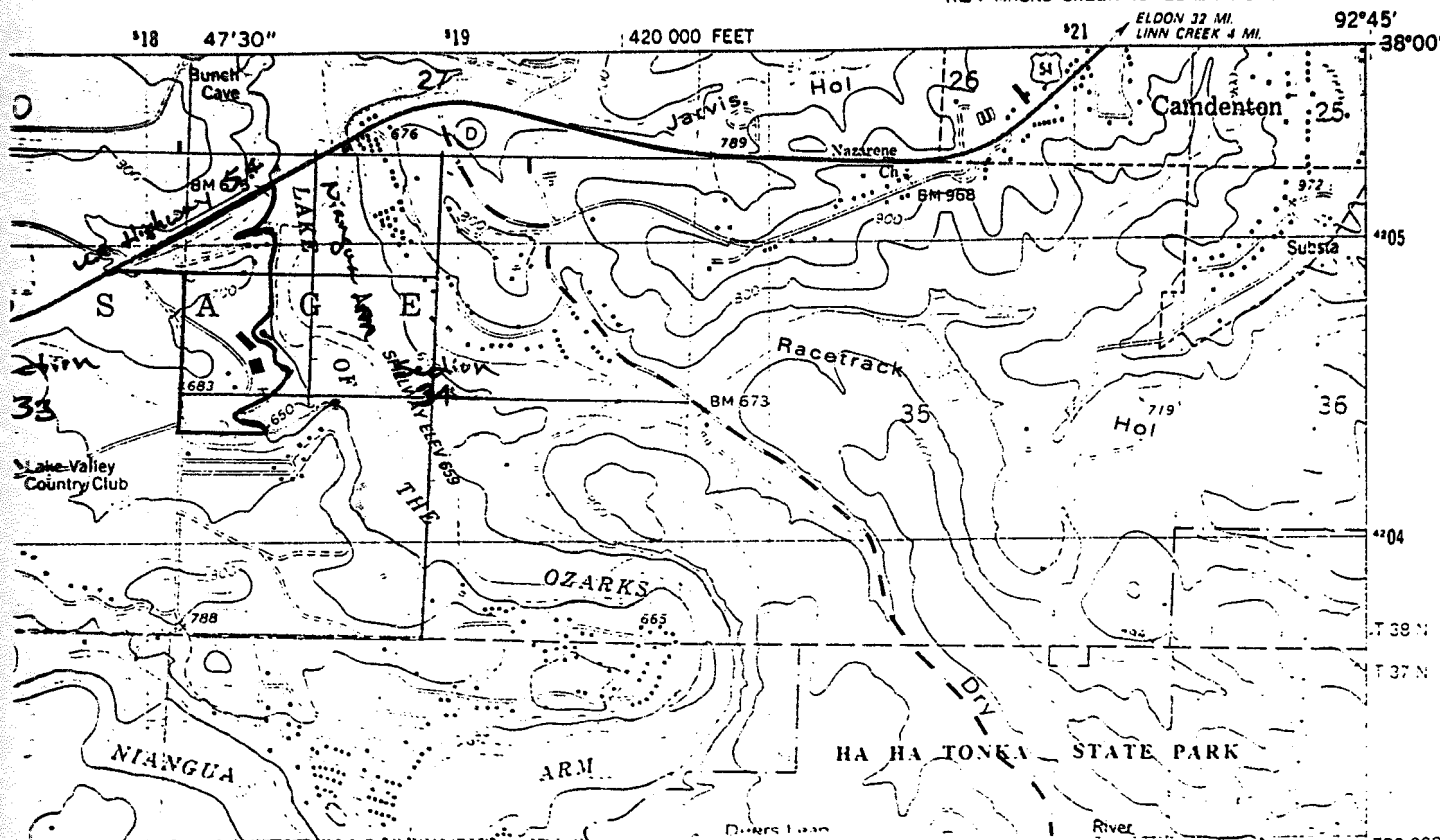
MAP OF SERVICE AREAS
