STATUS REPORT, AGREEMENT REGARDING CONSOLIDATION, AND PROPOSED PROCEDURAL SCHEDULE

COMES NOW Confluence Rivers Utility Operating Company, Inc. ("Confluence Rivers"), on behalf of itself and all other parties, the Staff of the Commission ("Staff"), the Office of the Public Counsel ("OPC"), and Lake Perry Lot Owners' Association ("Owners' Association"), and for the parties' Status Report, Agreement Regarding Consolidation, and Proposed Procedural Schedule, respectfully states as follows to the Missouri Public Service Commission ("Commission"):

- 1. On November 2, 2017, Confluence Rivers filed an Application and Motion for Waiver for Confluence Rivers to acquire certain water and sewer assets of various water and sewer systems, along with a certificate of convenience and necessity.
- 2. On March 6, 2018, Staff filed its Staff Recommendation and an associated Memorandum. On March 15, 2018, OPC filed a Response to the Staff Recommendation and requested an evidentiary hearing and the scheduling of a prehearing conference. The Owners' Association also filed a request for an evidentiary hearing on Confluence Rivers' Application.
- 3. A prehearing conference was held jointly in both proceedings on May 1, 2018. Counsel for all parties were present at the prehearing conference. Following the prehearing conference, the parties discussed Confluence Rivers' intent to amend its Application to include

additional service areas, consolidation of the water and sewer cases, OPC's request for public hearings, and other matters.

4. The parties agree that Case No. WM-2018-0116 and Case No. SM-2018-0117 should be consolidated, with WM-2018-0116 designated as the lead case. And the parties propose the following schedule for the initial processing of the consolidated cases:
