On behalf of Aquila, Inc. ("Aquila" or "Company"), I am providing herewith to the Missouri Public Service Commission ("Commission") for filing in electronic form certain tariff sheets consisting of revised steam rate schedules which are designed to increase the annual steam revenue of the Company's Aquila Networks – L&P steam operations by approximately \$5 million, exclusive of applicable franchise and occupational taxes. The rate schedules bear a date of issue of May 27, 2005, and an effective date of June 26, 2005.
