**ORDER SETTING PROCEDURAL SCHEDULE**

Issue Date: March 5, 2007

Effective Date: March 5, 2007

On August 23, 2007, Big River Telephone Company, LLC, filed a complaint against Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri. Big River alleges that AT&T Missouri is charging Big River rates over those allowed by their interconnection agreement. AT&T Missouri denies the allegations.

On February 28, 2007, the parties filed a Joint Motion to Establish Procedural Schedule. Commission Rule 4 CSR 240-2.080(15) allows parties ten days to respond to pleadings. But because no parties oppose the motion, the Commission will dispense with the ten-day period for responses, and the Commission will consider Staff's proposed schedule unopposed. The Commission finds Staff's Proposed Procedural Schedule reasonable, and will adopt it, except for the proposed hearing dates, which are unavailable.

**IT IS ORDERED THAT:**

1. The parties' Joint Motion to Establish Proposed Procedural Schedule is granted in part and denied in part, and the proposed schedule is adopted, except as otherwise noted in this order.
