ORDER GRANTING JOINT MOTION TO CANCEL HEARING

An evidentiary hearing concerning CenturyTel of Missouri, LLC and Spectra Communications Group, LLC d/b/a CenturyTel's tariffs regarding remote call forwarding services and its related dispute with Socket Telecom, LLC, is scheduled to begin on October 18 and 19, 2007. On October 15, CenturyTel and Socket filed a joint motion asking the Commission to cancel the evidentiary hearing and instead accept submission of the case on the prefiled testimony, as well as briefs to be filed on October 31. CenturyTel and Socket indicate their willingness to stipulate to the admission of the prefiled testimony into evidence, and to waive their right to cross-examine the witnesses offering that testimony.

The only other active party to this case is the Staff of the Commission. The motion represents that Staff neither opposes nor supports the motion. The Office of the Public Counsel is, by statute, a party to this, and all other cases before the Commission, but Public Counsel has not taken an active role in this case.

The joint motion to cancel the evidentiary hearing is reasonable and is unopposed.

The Commission will grant the motion and will accept submission of the case based on the prefiled testimony.

- 1. The evidentiary hearing scheduled for October 18 and 19, 2007, is cancelled.
