ORDER SETTING PROCEDURAL SCHEDULE

Effective Date: March 26, 2007

On February 14, 2007, Socket Telecom, LLC and Socket Holdings Corporation d/b/a Socket Internet filed a Request to Suspend or Reject Proposed Tariff Sheet. The Commission granted Socket's request, and suspended the above-referenced tariffs filed by Century Tel of Missouri, LLC d/b/a CenturyTel and Spectra Communications Group, LLC d/b/a CenturyTel. Chariton Valley Telecom Corporation and Mark Twain Communications Company intervened.

On March 22, 2007, the parties filed a Joint Motion to Establish Procedural Schedule. Commission Rule 4 CSR 240-2.080(15) allows parties ten days to respond to pleadings. But because no parties oppose the motion, the Commission will dispense with the ten-day period for responses, and the Commission will consider the proposed schedule unopposed. The Commission finds the Proposed Procedural Schedule reasonable, and will adopt it.

IT IS ORDERED THAT:

1. The parties' Joint Motion to Establish Proposed Procedural Schedule is granted, and the proposed schedule is adopted.

2. The procedural schedule is ordered as follows:

Direct Testimony, all parties except Staff	May 21, 2007
Rebuttal Testimony, including Staff	July 6, 2007
Surrebuttal Testimony, including Staff	July 30, 2007
List of Issues, List of Witnesses, Order of Cross-Examination, and Order of Opening Statements	August 7, 2007
Statement of Positions	August 13, 2007
Evidentiary Hearing	August 27-28, 2007 8:30 a.m.

3. The hearing will be held at the Commission's offices in the Governor Office Building, Room 310, 200 Madison Street, Jefferson City, Missouri, a facility that meets the accessibility standards of the Americans with Disabilities Act (ADA). 4. The parties are directed to comply with the conditions set out in this order.
5. This order shall become effective on March 26, 2007.
