ORDER GIVING NOTICE OF CONTESTED CASE, DIRECTING ANSWER, DIRECTING FILING, AND DIRECTING STAFF INVESTIGATION

Issue Date: May 24, 2012 Effective Date: May 24, 2012

On May 23, 2012, Duane Farrant ("Complainant") filed a complaint with the Missouri Public Service Commission ("Commission") against CenturyLink ("Respondent"). A copy of the complaint accompanies this notice. This is a contested case¹ pursuant to Section 386.390, RSMo 2000, although the statutes and Commission regulations allow for a decision without a hearing.² Since the Complainant does not state in his complaint whether the amount in dispute is less than \$3,000, the Complainant will be directed to file a statement with the Commission providing this information to determine whether this case should proceed under the small formal complaint procedures.³

The Commission will set a deadline for Respondent to file an answer. In the alternative, the Respondent may file a written request that the complaint be referred to a neutral third-party mediator for voluntary mediation of the complaint. Upon receipt of a

request for mediation, the 30-day time period shall be tolled while the Commission ascertains whether or not the Complainant is also willing to submit to voluntary mediation. If Complainant agrees to mediation, the time period within which an answer is due shall be suspended pending the resolution of the mediation process. Additional information regarding the mediation process is enclosed. If Complainant declines the opportunity to seek mediation, Respondent will be notified in writing that the tolling has ceased and will also be notified of the date by which an answer or notice of satisfaction must be filed. That period will usually be the remainder of the original 30-day period.

As required by Section 536.067(2)(f), RSMo 2000, the Commission informs the parties that the Commission's provisions governing procedures before the Commission, including provisions relating to discovery, are found at Commission Rule 4 CSR 240-2. Because the Complainant is not a regulated utility, the 60-day notice requirement established by Commission Rule 4 CSR 240-4.020(2) does not apply.

The Commission will also set a deadline for its Staff to complete an investigation and file a report.

THE COMMISSION ORDERS THAT:

- 1. Duane Farrant shall file a statement with the Commission, no later than June 23, 2012, stating whether the total amount in dispute with CenturyLink is greater or less than \$3,000.00.
- 2. The Commission's Data Center shall send, by certified mail, a copy of this notice and order and a copy of the complaint to CenturyLink at:

CenturyLink shall file an answer to this complaint, notice of satisfaction of the complaint, or request for mediation no later than June 23, 2012, and serve a copy upon the Complainant at the address listed within the enclosed complaint. All pleadings (the answer, notice of satisfaction of complaint, or request for mediation) shall be mailed to:

- 4. The Staff of the Missouri Public Service Commission shall investigate this complaint and file a report with the Commission no later than July 13, 2012.
- 5. The Commission's Data Center shall send a copy of this notice and a copy of the Commission's procedural rules to the Complainant.
 - 6. This order shall become effective immediately upon issuance.
