UNANIMOUS MOTION TO EXTEND TIME TO FILE POSITION STATEMENTS, LIST AND ORDER OF  
WITNESSES AND ORDER OF CROSS-EXAMINATION

Comes now the Staff of the Missouri Public Service Commission (Staff) in behalf of all parties to the above case, and for its Motion to Extend Time to File Position Statements, List and Order of Witnesses and Order of Cross-Examination, states the following:

1. On April 10, 2001, the Commission entered an Order Modifying the previous Procedural Schedule in this case. Pursuant to that modification, the Commission directed the parties to file their position statements, list and order of witnesses and order of cross-examination on June 18, 2001.


2. After the above Order was entered the parties entered into settlement negotiations and have expressed a desire to memorialize settled issues in a Partial Stipulation and Agreement to narrow the issues for hearing. The parties need additional time to draft the Partial Stipulation and Agreement for presentation to the Commission and also perhaps present a revised list of issues. In addition, Staff Witness Ron Bible is unable to participate in drafting Staff's position statement because he is out of state on National Guard duty until June 18, 2001.

3. Staff has contacted all the parties and they all support the extension of time requested in this Motion.

4. Therefore, for all the above reasons, the Staff respectfully requests that the Commission enter an Order allowing the parties until June 26, 2001, to file their position statements, list and order of witnesses, and order of cross-examination.
